Please read the following reservation conditions. You will need to sign your agreement to these conditions on the reservation form.

Insurance

We highly recommend trip insurance to cover things such as medical treatment, loss of property and cancellation charges. You can obtain insurance from many providers and one good source of information is the website www.insuremytrip.com.

If you cancel

If you cancel your participation on the tour, there will be a charge that varies according to the period of notice you give. Up to 120 days before departure the deposit and airline deposit only are forfeited. Thereafter a percentage of the total tour cost will be due:

Between 120 and 90 days:	25%
Between 90 and 45 days:	50%
Between 44 and 14 days:	80%
From 13 days or less:	100%

The day of cancellation is the day on which we receive a written and signed confirmation of cancellation by fax or post.

If we cancel

Your tour is based on a minimum number of 30 travelers and may be canceled if that number is not reached at 120 days prior to the tour departure. If OPUS Tours cancels the tour, you will receive a full refund for all deposits made until that time. OPUS Tours will not be responsible for any penalties you may incur from canceling or changing your tour flights due to the cancellation of the tour. It is highly recommended that you purchase trip insurance to cover trip cancellation and other tour needs.

Notice

OPUS Tours acts only as an agent for the suppliers of travel, conveyance, transport, accommodations, or other service and has no responsibility for any delays, delayed departure or arrival, missed carrier connections, loss, death, damage or injury to person or property, or accident, mechanical defect, failure, or negligence of any nature howsoever caused in connection with any accommodations, transportation, or other services or for any substitution of hotels or for common carrier equipment, with or without notice, or for any additional expenses occasioned thereby. Baggage and personal effects are the sole responsibility of the owners at all times. The right is retained to decline to accept or to retain any person as a member of this trip at any time, when such action is determined by MT to be in the best interests of the health, safety, or general welfare of the tour group or of the individual, subject only to the requirement that the portion of the total amount paid that corresponds to the unused services and accommodations be refunded. **Passengers requiring extraordinary assistance must be accompanied by someone who can and will be totally responsible for providing all required assistance.** If the entire program is cancelled for any reason, participants shall have no claim other than for a full refund. By forwarding the deposit, the passenger certifies that he/she has no condition that would create a hazard for himself/herself or other passengers and accepts the terms of this contract. The airlines and other transportation companies concerned are not to be held responsible for any act, omission, or event during the time passengers are not on board their conveyances. The passage contract in use, when issued, shall constitute the sole contract between the company and the passenger and/or purchaser of this trip. By embarking upon his/her travel, the traveler voluntarily assumes all risk involved in such travel, whether expected or unexpected. Traveler is hereby warned of the above risks as well as possible medical and climatic disruptions, and the possibility traveler may be unable to travel because of personal emergency.

Contract Waiver of Liability

In consideration of allowing my participation in this tour, I agree to hold OPUS Tours harmless and to release it from liability as well as its agents, employees, officers, directors and affiliated companies or subcontractors for any and all actions, debts, suits, claims, and demands of any kind in connection with my participation in this tour either now or in the future. All terms and conditions shall be governed by the laws of and in the state of New Jersey.
